ORDER

A petition filed by Smti. Bhanumati Ray M/o Late UB Constable Bhaskar Ray of Vill.- Chandamari, P.O- Balapet, P.S- Sarbhog, Dist.- Barpeta, Assam has been received by this office on 27-03-2023.

As Per PRANAM Act 2017 and PRANAM (Amendment) Act 2021, both the parties were directed to appear in the office of the Director, Bureau of Investigation (EO), Assam on 1st June,2023. Accordingly both the parties were present and heard both the parties.

The petitioner Smti. Bhanumati Ray stated that she has applied for financial support to maintain her livelihood from her daughter-in-law i.e. from the compassionate family pension of Smti. Jonali Das W/o of Late UB Constable Bhaskar Ray. The petitioner stated that presently she is getting family pension of an amount of Rs.10,114.00 per month (of her late husband Novel Ray as per the income certificate and Bank statement furnished by the petitioner) which is not sufficient.

The Respondent Smti. Jonali Das W/O:-Late Bhaskar Ray, UB Constable , BI(EO), Assam agreed that she will have no objection to go by the rules of the PRANAM Act, 2017 and PRANAM (Amendment) Act 2021 by giving 10% of her compassionate family pension per month to her mother-in-law.

Perused the prayer of Smti. Bhanumati Ray and found that being an aged lady (about 60 years) , it will be very difficult to maintain herself with the only pension money of her husband , as day to day medical expenditure are also there.

Considering all aspects of the matter and after careful consideration of the Prayer submitted by the petitioner, I have applied my mind and come to the conclusion to **deduct 10% of the Compassionate Family Pension** of Smti. Jonali Das wife of deceased UB Constable Bhaskar Ray as per PRANAM Act. 2017 and PRANAM (Amendment) Act 2021 as maintenance cost to her mother-in-law Smti. Bhanumati Ray.

Both the parties were agreed upon the Proposal and accordingly Smti. Jonali Das Respondent and Smti. Bhanumati Ray petitioner has put their Signature on the Written statement of the Hearing and as witness Sri Manzoor Ahmed, APS, Dy.SP cum Officer –in – charge BIEO P.S. , Smti.Niva Keot Sub-Inspector and Daud Raja Ahmed , Sr. Assistant put their signature as witness. Also Smti. Jonali Das w/o Late Bhaskar Ray Respondent has put her signature in the individual declaration.

This Order will come into effect from the month of April/2023.

Further, it is seen that the decision taken is justified for both the Parties.

This Order have been Passed in Compliance of an appeal U/S-7,8&9 as Per PRANAM Act-2017 and PRANAM (Amendment) Act 2021.

With the above direction Smti. Bhanumati Ray's application is disposed off.


