**ORDER**

No. UC-80/2021/27 :- Under the provisions of PRANAM Act, 2017 and rules made there under Smti Bikan Das, a resident of vill- Koria P.O- Koria, Dist- Nalbari, Assam, submitted a petition on 30/08/2022. She is the mother in law of Smti. Sikha Baishya Das and mother of Late Sapan Das, who was a grade IV employee of the office of the undersigned and died in an accident. In order to derive whether the case is fit to be under the provisions of the said Act and to ascertain the genuineness of the same a committee with five numbers of Officers and staff was formed. The committee has submitted the report and recommends the undersigned to approve the application of Smti. Bikan Das. The gist of observations by the committee are as follows :

1. The committee had taken hearings of both the parties.
2. Both the petitioner and respondent have agreed to follow the order to be given by the appropriate authority.
3. The petition is under the provisions of law.

Hence giving careful consideration to all aspects, I have come to the conclusion that 10% of the gross salary is to be deducted per month from the Compassionate family pension of Smti. Sikha Baishya Das as cost of maintenance of Smti. Bikan Das under the provisions of PRANAM Act, 2017.

This order had come into effect from 01/05/2023.

This order has been passed in compliance with the petition u/s 13 of the PRANAM Act, 2017.

With the above direction the petition of Smti. Bikan Das is disposed off.
